Dear Tracy Smith:

On October 29, 2021, Canadian Pacific Railway Limited, et al. (CP) and Kansas City Southern et al. (KCS) (collectively, Applicants) filed an application with the Surface Transportation Board (Board) seeking authorization for CP to acquire KCS.

Because the proposed acquisition has the potential to result in significant environmental impacts, the Board's Office of Environmental Analysis (OEA) has determined that the preparation of an Environmental Impact Statement (EIS) is appropriate. This letter is to formally announce that the Board has issued a Notice of Intent (NOI) to prepare an EIS for this proceeding (<https://cp-kcsmergereis.com/docs/cp-kcs-noi.pdf>). In addition to announcing that the Board will prepare an EIS for this proceeding, the NOI also requests comments on the scope of the EIS and presents a schedule for public scoping meetings; interested parties are encouraged to participate.

Scoping is the first step of the EIS process. Scoping is an open process to determine the range of issues that should be examined and assessed in an EIS. Comments submitted during scoping will assist OEA in defining the range of alternatives and potential impacts to be considered in the EIS.

OEA will hold six online public scoping meetings at the dates and times listed below (all times are listed in Central Standard Time). There is no need to attend more than one meeting,

but all are welcome to attend as many meetings as desired. Interested parties can access the online meetings in one of two ways:
