“CONSIDER AND TAKE APPROPRIATE ACTION ON A RESOLUTION AND ORDER AUTHORIZING THE COUNTY TO ENTER INTO A TAX ABATEMENT AGREEMENT PURSUANT TO THE COUNTY’S GUIDELINES AND CRITERIA UNDER THE PROPERTY REDEVELOPMENT AND TAX ABATEMENT ACT, CHAPTER 312 OF THE TEXAS TAX CODE AS REQUESTED BY CEDAR RANGE LLC FOR APPROXIMATELY \$203,000,000 IN IMPROVEMENTS RELATED TO THE GENERATION OF ELECTRICAL ENERGY UTILIZING SOLAR PANELS. THE PROPERTY SUBJECT TO THE ABATEMENT AGREEMENT COMPRISES APPROXIMATELY 1,100 ACRES AND IS LOCATED IN WESTERN HOPKINS COUNTY, SOUTH OF INTERSTATE 30 AND WEST OF FARM ROAD 275 SOUTH WITHIN THE HOPKINS COUNTY CEDAR RANGE REINVESTMENT ZONE NUMBER 1.
